INTERNET USE AGREEMENT, WAIVER, AND RELEASE**

The Internet

The East Windsor Scout Hall Building Committee, Inc. ("EWSHBC") is offering access to the Internet through the EWSHBC's wireless system.

The Internet is a worldwide communications network through which users may communicate with other Internet users through textual, graphic, and audio transmission. The EWSHBC's sole intent in providing access to the Internet is to further educational goals and objectives

The EWSHBC cannot prevent access to questionable material either intentionally or unintentionally. Access to textual, graphic, and/or auditory information, which is pornographic, sexually explicit, illegal, defamatory, and otherwise offensive to the user or others is strictly prohibited by this Agreement. It is therefore the responsibility of users to set appropriate standards concerning the access and use of material contained on the Internet. The user must sign this Internet Use Agreement, Waiver, and Release form in order to be granted access.

All users under the age of 18 must be under the supervision of an adult that has signed this Agreement.

Conditions and Rules of Use

Access to the Internet through the EWSHBC's wireless system, is not a right, it is a privilege. Accordingly, all users must comply with the following conditions and rules of use:

1. Anyone wanting access to the Internet through the EWSHBC wireless system must sign an Agreement, Waiver, and Release form.
2. Users shall not access, view, transfer, or store any material in any form which is pornographic, sexually explicit, illegal, defamatory, or potentially offensive to others.
3. Users who unintentionally access such material shall immediately terminate such access, shutting off your computer, if necessary.
4. Users shall not harass, insult, or attack others.
5. Users shall not damage computers, computer systems, computer networks, or computer data.
6. Users shall not share the access code provided them by the EWSHBC with any other person.
7. Users shall abide by all federal, state, or local laws.

Violation of any of the foregoing conditions and rules of use shall be grounds for immediate termination of Internet access privileges.

WAIVER AND RELEASE

I hereby consent to the above conditions and rules of use. **I understand that the Internet contains material, which is pornographic, sexually explicit, illegal, defamatory, and otherwise offensive to some people.** I understand that it is impossible for the EWSHBC to completely prevent access to such material. By signing this Agreement, I agree I will take no legal action, now or in the future, against the EWSHBC, officers, administrators, agents, and volunteers caused by, or resulting from my access to the Internet. I hereby release the EWSHBC from any liability, whatsoever which may arise as a direct or indirect result of my access to the Internet. I am solely responsible for any harm that may come to my computer from accessing the Internet through the use of the EWSHBC wireless system, including, but not limited to, viruses, malware of any kind, undesirable programs, etc.
